President's Message by Scott M. Schmidt, CFSP Chief Coroner--Orleans County, New York

Sometimes, WE NEED a Reality Check

While talking with Ontario County Coroner Kevin Henderson about his speaker line-up for the Fall 2013 Conference, he expressed concern about a speaker for the dinner presentation. We chatted about a few ideas and had some interesting conversation about speakers in the past and finally, he somewhat sheepishly mentioned an idea he had been thinking about for quite some time.

Kevin methodically described one of his cases which left a lasting impression upon him. The case involved a suicide of a young man who was found by his (the deceased's) brother after he had not reported to work. Kevin thought that perhaps hearing the story from the 'other side' (meaning from the surviving brother's point of view), might be an interesting topic for our dinner speaker. I pondered this and told him that usually we try to keep the dinner presentation light and up-beat after a day full of lectures. I suggested that he might find someone who was up-beat to end the day on a 'high note' and leave people excited to go back on Sunday morning. However, I also told him that it was his conference and I would go along with whatever decision he would make. Kevin made his decision and this is what happened.

Mr. Thomas Burns, a Codes Investigator for the NYS DDSO in Macedon, provided us with some hard-core reality. He shared a

story about his brother John Burns, the jokester of his family. John had some personal problems, but had turned his life around and was working to achieve his full potential in life, carrying the mantle of adult responsibility proudly. Tom also shared a video with us showing John reciting a "thank-you" message of sorts for his parents on the occasion of their anniversary. His message was from the heart, delightful, funny and in every regard priceless to his parents, because it was a genuine gift which could not be bought or duplicated.

As Tom continued with his presentation, he described in painful detail how he received a phone call to check on John as he had not reported to work as usual. Tom re-lived for us verbally, and with great precision, creating for us a horrifying visual representation of seeing his brother on the couch and discovering that he was not, '... wearing a hat..' but rather the after-effects of taken his life with a gunshot wound to the head. He continued his story about the interrogation that ensued by law enforcement, EMS, and finally by Coroner Henderson who, after the requisite and obligatory questions and investigatory interview, did something human. Kevin gave Tom his phone numbers and as a human being--not a Coroner, extended the invitation to call him anytime to talk or meet for coffee.

We all know that we have 'routine' cases. We have routine unattended deaths, routine homicides, routine this and routine that. We all get into our routine mode and sometimes callously do what we need to do to get our job done and put it behind us. We often lose sight of the fact that a death of someone's family member is NEVER routine to them! Our interaction with that family during one of the most difficult, emotional and devastating times of their lives is of utmost and paramount importance. Not for the sake of the case, but for the sake of their emotional well-being and moving on with life in a healthy direction. By taking a few extra moments to care, to share that we are also human beings and not robots, it can and does make a world of difference.

You learned how important that difference was in the life of Tom and you learned how simple it was to make that difference. There wasn't a person in that room during the presentation, who didn't feel an emotional connection with Mr. Burns and who at some point throughout his talk, didn't have their eyes well-up with a tear or two.

I thank you Tom Burns for having the courage to share the story of your brother John and of your journey through tragedy and grief with us. I thank Ontario Coroner Kevin Henderson for having the courage and wisdom to be a human being...a friend to this man, during the most difficult time in his life. And I thank both of them for showing us that we NEED to stay grounded in reality because our immediate and long-term actions can influence people beyond belief...good or bad. We must constantly remember that our job IS a terrible reality for many people. Taking an extra moment to assure the families we serve that we too, are human and genuinely care, is such a powerful and compassionate thing to do. That action alone, verbally and in-person, can help a grieving family more than you could ever imagine. Take a moment next time you have the chance and privilege to do so, to keep yourself grounded, keep it real, and extend your human side to someone who needs it.

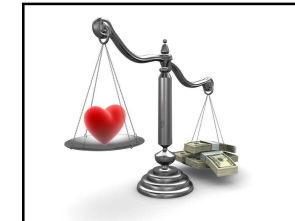

STUDENT MEMBERSHIP

In the hopes of expanding long-term membership in the Association, during its September 20, 2013 meeting, the Board of Directors approved a series of proposed Amendments to the NYSACCME Bylaws that would authorize the creation of a student membership. To become a student member, an individual must be enrolled at an accredited institution in a Premed undergraduate program, Medical School (residency), Mortuary Science program, Forensic Investigation program, or Criminal Justice program, or such similar program as approved by the Board. Students who wish to become a member will have to submit an application, which will include proof of enrollment in a qualifying educational program. Further, the student must be nominated for membership by a current member of the association. A majority of the Board must then favorably pass on the application. If the student fails to maintain enrollment in a qualifying program, then his /her membership will be terminated.

Under the Bylaws, the Board will determine the student membership fee, which may be lower than the standard membership fee. The Board is also discussing whether student members should be charged the same rate to attend conferences as other members who are already practicing in their respective fields and earning income. The Board welcomes input from any members who wish to share their opinion regarding student membership fees and rates. The issue will be discussed at the Board's next regular meeting, to be held in January of 2014.
