President's Message by Scott M. Schmidt, CFSP Chief Coroner—Orleans County, New York

I've been in Funeral Service since 1982. I've been an elected Coroner in my County since 1990. There are many things that have left an impact on me and my life over the years but only a certain few stand out.

Living in a small community is a blessing, but sometimes it can also be a curse. I'm sure you know what I mean. People find out things you wish they hadn't. People somehow know your every move and some can even tell you what you had for dinner last night. This same curse is often at the same time that blessing I spoke of first. You become close to people, you become part of a unique and extended family. You become part of that community....the community becomes your family as well.

This past week I had the honor of being part of my community. 24 year old Jason Johnston was killed in Afghanistan by an IED. Jason was a member of the Albion community. He was fighting for me, for my family, for our nation. His death was the first combat-related death of a serviceman in Orleans County since Vietnam.

As the family's chosen Funeral Director, I interfaced with the Army, Police, Fire, Patriot Guard, and many other people and agencies who came together as a family to honor this young man who died for our freedom. Being part of the community is something we do as part of our jobs, but is also something we should be proud of as well. I have NEVER been so proud of my community. My community...the one

who allowed 2400 school children to line the street and wave flags as the procession went past the school buildings. My community...the one that had nearly every flag lowered to half staff out of respect. My community...the one which came out in frigid temperatures and blowing snow to line the roads coming home from the airport to welcome home a hero. My community...people who will never forget the sacrifice so many people are making so that we may all speak our minds or write articles such as this. I've never been so proud to be part of a community...MY community. May you experience the love and the comfort of community in the New Year. God bless our Troops and God bless America!

We have already secured a contract for one of the nicest properties in the Central New York Region and

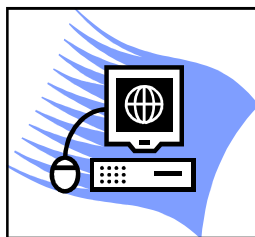
NYSACCME is pleased to announce that the Fall 2010 Educational Conference will be held at the Genesee Grande Hotel.

A new Store has been fashioned and the manager will be John Tyler from Crime Scene Clean-

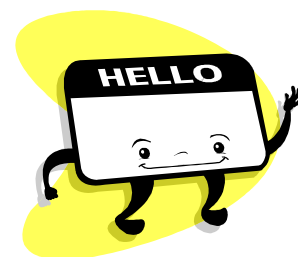
