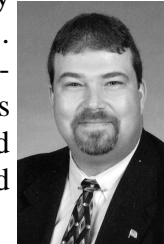

Kenneth R. Hamm, 77 current Columbia County Coroner, of Gallatin, New York died on Tuesday December 11, 2007 at his residence.

He was born on October 21, 1930 in Gallatin the son of Rossman J. and Marion O. (Bradley) Hamm.

Mr. Hamm was a graduate of Pine Plains Central School, class of 1948.

A corporal, he served with the United States Army from 1954 – 1956 stationed in Germany. He was a member of the Cadby – Shutts VFW Post #7552 in Hillsdale, N.Y. and the Shacameco American Legion Post in Pine Plains, N.Y.

After his military service he became employed by the Kimberly Clark Corporation in Ancram, N.Y. He retired as shift foreman in 1993 after 36 years.

Ken was also very active in community affairs. Along with his military affiliations he was also a longtime contributing member of St. John's Lutheran Church in Ancram. He was an over 50 year member of the Ancram Fire Company and was a member and past president of the Columbia County Volunteer Firefighters Association.

He had served as the Ancram Town Clerk from 1962 – 1975 and served as town supervisor for Ancram from 1976 – 1981. From 1983 to the present he had served as Columbia County Coroner. Ken was also a member and treasurer of the New York State Association of County Coroners and Medical Examiners.

On August 25, 1957 in New York City he married Denise (Jones) Hamm who survives him at home.

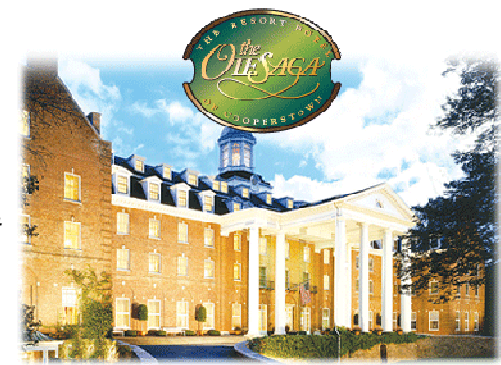

From the west (Buffalo/Syracuse): Take Exit 30 off the New York State Thruway (I-90) at Herkimer and take Route 28 South to Cooperstown. After entering the village, turn left onto Chestnut Street. Follow Chestnut Street through the stoplight to Lake Street. Turn left onto Lake Street. The Hotel is located on the right overlooking Lake Otsego.



From the east (Albany): Take the New York State Thruway (I-90) to Exit 25A and I-88 to Duanesburg (5 miles), Exit 24 then Route 20 West to Route 80 South to Cooperstown. After entering the village, The Otesaga is on the left, just past The Golf Course on Lake Street.

From the south (Binghamton/Oneonta): Take I-88 to Oneonta, Exit 17 to Route 28 North to Cooperstown. After entering the village follow Chestnut Street through the stoplight to Lake Street. Turn left onto Lake Street. The Hotel is located on the right overlooking Lake Otsego.

From the south (NYC): Take the New York State Thruway (I-87) north. At Albany, continue on New York State Thruway (I-90 West) to Exit 25A (I-88 Binghamton) to Exit 24 (Duanesburg). Agency (FEMA) to plan for and manage mass fatalities in any natural or man-made disaster. NFDA had previously discussed with Rep. Richardson on several occasions our concerns with the lack of any federal mass fatality management plan. In response, she has introduced H.R 6566, a bill entitled “*Mass Fatality Planning and Religious Considerations Act*’.

The text of the entire bill is as follows:

Congress finds the following:

(1) *Emergency preparedness often plans for how to prepare and provide for survivors of a natural disaster, act of terrorism, or other man-made disaster, but fails to plan for how to prepare for and respond to mass fatalities that result from such an incident .*

(2) *Funeral homes, cemeteries, and mortuaries could be overwhelmed should mass fatalities arise from a natural disaster, act of terrorism, or other man-made disaster.*

(3) *Different religions have different customs surrounding death; for example, the Jewish and Muslim religions call for burial of the deceased not later than 48 hours after death Section 504 of the Homeland Security Act of 2002 (6 U.S.C. 314) is amended by adding at the end the following new subsection:*

(c) Preparedness for Mass Fatalities- In carrying out this section, the Administrator shall provide guidance to and coordinate with appropriate individuals, including representatives from different communities, private sector businesses, non-profit organizations, and religious organizations, to prepare for and respond to a natural disaster, act of terrorism, or other man-made disaster that results in mass fatalities.’”
