## INTRODUCING NYSACCME PUBLIC INFO OFFICERS

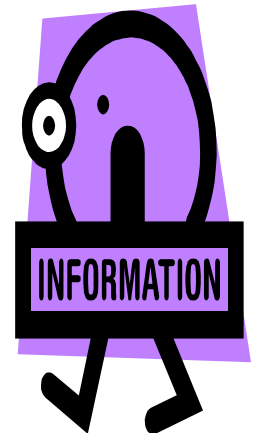

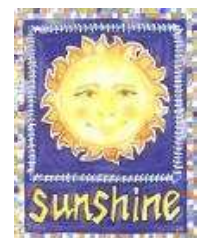

### Every Scene-Every Death-Every Time

In 1998 the Federal Required Referral Law went into affect which required all deaths that occurred in a hospital be referred to their federally designated Organ Procurement Organization. To ensure compliance it was attached to the Conditions of Participation under Medicare and Medicaid Service. This law was created to ease the shortage of much needed organs and tissues because hospitals failed to voluntarily cooperate to develop policy and procedures that would refer these deaths.

The New York Alliance for Donation is starting a large Public Awareness Campaign to promote the Donor Registry and give people the information needed to make their decision to register as an intended or consented donor. Public transportation, college campuses as well as the Voter Registration Bill have been targeted. According to DMV, 8000 New Yorkers a week are designating themselves as donors. Many of these people will register as donors, all for naught if they die outside of a hospital.

While some counties have adopted policy and procedures to refer all deaths pronounced at the scene, many have not. Every day in the news we learn about a 16 year old killed in a crash, or pedestrian verses car death, snowmobile accidents, motorcycle fatalities, skiing mishaps, sudden cardiac deaths with minimal down-time. All these scenarios fall under the jurisdiction of the coroner or medical examiner and represent a lost donation opportunity for families. Were these people on the Donor Registry? We will never know because their deaths were not referred and their right to decide to donate was taken away from them.

We all live and work within the confines of law, mandates and requirements in our jobs. Most laws, mandates and requirements are rigid and inflexible with no "wobble room". We still have "wobble room" and have the opportunity to create unique policies and procedures based on a County's configuration, i.e. coroner system, ME system, central morgues and autopsy hospitals, central ME offices, or contractual agreements with surrounding counties.

Now is the time to voluntarily create policy and procedures in conjunction with your local recovery agency to recognize the efforts of those who have taken the time to consider all types of donation. Their legacy lives on for their family and the family of the recipient. The Counties who have been pro-active and have already created policies and procedures are well ahead of the game and when legislation is enacted, their referral module can affect the way the mandates are created. Voluntarily creating policies and procedures now to recognize the NYSDOH Donor Registry could stall rigid legislation (already in the works) that would take away your control over your County's procedures.

We, as coroners and medical examiners, are fortunate to have an organization such as NYSACCME that has provided on-going education concerning donation. Steadfast support from the donation community bringing updated education to the membership has been increasing over the years.

In the end, this is not about *you (as coroner/ME) or about me (OPO or recovery agency)* it is about a person having a right to make the decision to donate, whether they die in a hospital or outside the hospital setting. Now is the time to work with your recovery agency to create policies and procedures that encompass "**Every Scene – Every Death – Every Time**". As public officials your communities are depending on you to protect their rights.
